


Planning Downtown's Continued Boom

At CCA's Housing, Land Use & Development Committee meeting on Wednesday Department of City Planning staff provided updates on various projects.

First, Alan Bell, Charlie Rausch, and Phyllis Nathanson presented the proposed Master Planned Development (MPD) Ordinance. Made for campuslike unified developments, MPDs will allow tailormade zoning to govern new projects. CCA has formed a working group to formulate amendments to the proposed ordinance to ensure that Downtown projects can make use of this new tool.

Next, **Simon Pastucha** updated CCA on the Urban Design Studio, which will add 2 new staff members this year. The Studio integrates principles of urban design with innovative policy, and Simon is currently working with the Department of Public Works to streamline streetscape improvement procedures.

Finally, **Patricia Diefenderfer**, **Nicholas Maricich**, and **Bryan Eck** provided general updates on the Downtown Community Plan. The recent transformation of Downtown into Los Angeles' newest urban residential community has created new planning opportunities and challenges, and they hope to incorporate CCA feedback into their work.

CCA's Housing Showcase and Panel

At CCA's **Housing Showcase and Panel** today, CCA members previewed six new-to-market Downtown housing projects.

Tom Gilmore, Principal at Gilmore Associates, emceed the discussion. Kevin Farrell, the EVP & COO of Century West Partners, Frank Frallicciardi, Director of Development at Forest City West, Julio Morales, the VP of Investments at Equity Residential, Con Howe, Managing Director of City View Los Angeles Fund, Daniel Taban from JADE Enterprises, and Bill Witte, President of Related California, discussed the Downtown housing market.

Overall, the panel had a positive outlook. With 5,000 units coming online, panelists mentioned the need to differentiate housing products. Meanwhile, demand for residential options remains high, with recent sales topping \$600 per square foot. This rise in price will likely continue, as more Angelenos come to see Downtown as an amenitized, urban neighborhood. Challenges remain, however, with the cost of building parking exceeding \$30,000 per space. The panelists all agreed that urban design and walkability should remain priorities.
